# Privacy Statement (French)

Association Canadienne des Vétérinaires Porcins is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Association Canadienne des Vétérinaires Porcins Web site and governs data collection and usage. By using the Association Canadienne des Vétérinaires Porcins website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

Association Canadienne des Vétérinaires Porcins collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Association Canadienne des Vétérinaires Porcins also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites. There is also information about your computer hardware and software that is automatically collected by Association Canadienne des Vétérinaires Porcins. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Association Canadienne des Vétérinaires Porcins for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Association Canadienne des Vétérinaires Porcins Web site.

# **Use of your Personal Information**

Association Canadienne des Vétérinaires Porcins collects and uses your personal information to operate the Association Canadienne des Vétérinaires Porcins Web site and deliver the services you have requested. Association Canadienne des Vétérinaires Porcins also uses your personally identifiable information to inform you of other products or services available from Association Canadienne des Vétérinaires Porcins and its affiliates. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Association Canadienne des Vétérinaires Porcins may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Association Canadienne des Vétérinaires Porcins, and they are required to maintain the confidentiality of your information.

Association Canadienne des Vétérinaires Porcins does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent. Association Canadienne des Vétérinaires Porcins keeps track of the Web sites and pages our customers visit within Association Canadienne des Vétérinaires Porcins, in order to determine what Association Canadienne des Vétérinaires Porcins services are the most popular. This data is used to deliver customized content and advertising within Association Canadienne des Vétérinaires Porcins to customers whose behavior indicates that they are interested in a particular subject area.

### **Use of Cookies**

The Association Canadienne des Vétérinaires Porcins Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Association Canadienne des Vétérinaires Porcins pages, or register with Association Canadienne des Vétérinaires Porcins site or services, a cookie helps Association Canadienne des Vétérinaires Porcins to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
